Dear colleagues,

You are kindly asked by the Draughts federation of Russia to include in the agenda of the General Assembly taking place in Izmir on 11 October the following issue:

-consideration of the Appeal (complaint) from a citizen of the Russian Federation, Andrey Fomin, against CPI about the reversal of the results of the first World Composition Championship (section “problems-64” (64-PWCP-1).

The essence of the Appeal presented by A. Fomin and supported by the DFR.

The Appeal.

Dear Messrs H.Otten, F.Teer and other representatives of the GA,

The GA-2013 which took place on 23 September, 2013, in Wageningen, approved the CPI report, as it is written in the GA-2013 Minutes placed 10.01.2014 on the FMJD website.

By this decision, the GA-2013, unfortunately, confirmed the results of the first world championship on problems-64 (64-PWCP-1), which were accepted on 06.08.2013 in Bielawa (Poland) by the EB-meeting because, I believe, the EB, in fact, was deceived by the CPI.

In the 64-PWCP-1 the conflict arose as the results of both the falsification made during the 64-PWCP-1 and the judgment by one of judges in contradiction with the 64-PWCP-1 regulations.

Both violations were made against me.

I protested in time, firstly to the CPI. But my protest to the CPI gave no result.

After the EB in Bielawa decisions were advertised on 01.09.2013, I did protest in second time (with the same motivation) to the CPI on 05.09.2013 (with copies to the FMJD leadership), and my protest was supported by the Draughts Federation of Russia. The CPI President, Mr

V.Shulga, answered to that protest later, on 20.09.2013, and in his answer again he tried to deceive, this time the Draughts Federation of Russia. And only in his answer to the President of

the Draughts Federation of Russia, Mr. A.Urgenson, in December 2013, Mr V.Shulga recognized the fact of the falsification, having written (in Russian): “a grain of the truth was lost”. By that recognition he, de facto, also admitted that the CPI had deceived the EB, while in

the CPI Statutes it’s clearly indicated: “The CPI President reports regularly to the CD, at least twice a year before the CD meetings about: ... Not yet solved conflicts, in particular when more

than one nationality is involved”.

The CPI hid from the EB the unresolved conflict, having violated its Statutes by that action.

That late answer of Mr V.Shulga was the reason why the Draughts Federation of Russia could not influence the GA decision: Mr V.Shulga answered on 20.09.2013 while the GA took place on 23.09.2013.

I can not agree with such an injustice made by the CPI towards me. I acted strictly within the order accepted by the FMJD but my protests were not considered properly.

The conclusions are:

Towards the result of the 64-PWCP-1 the EB in Bielawa took an incorrect decision, being deceived by the CPI leadership.

In its turn, the GA-2013 approved the Minutes of the EB-meeting in Bielawa, and, thus, the GA became also deceived by the CPI leadership regarding the results of the 64-PWCP-1.

Thus, the EB, the Draughts Federation of Russia and the GA were deceived by the CPI. That fraud from the CPI side has no precedent since the CPI creation.

By this appeal I strongly ask the next GA to reconsider the verdict accepted by the GA-2013 towards the 64-PWCP-1.

I ask the next GA to cancel the results of the 64-PWCP-1, which lost its juridical power towards the first, second and third places for the reason of two CPI actions: First: the CPI accepted both false judgments against me and illegal elimination of three compositions of mine;

Second: the CPI deceived both the EB and the GA, having hidden the unresolved conflict happened in the 64-PWCP-1.

Accordingly, such the GA decision has to be included in the next GA Minutes.

I fully support the EB decision (taken in March, 2014), by which the EB stopped the CPI activity. The present CPI-team clearly proved its incompetence not only by its acceptance of the false 64-PWCP-1 results but also its acceptance of the PWCP-5 for problems-100 results, in which four judges out of five judged deliberately against the Rules International, accepted by the CPI itself.

The present CPI team may not be considered as a really international committee because now the CPI consists of only former USSR problemists.

The GA is the highest level to accept a decision within the FMJD: it is the norm accepted in sports organizations both European and International. Therefore the next GA has the force to reconsider the incorrect decision, accepted by the GA-2013. Both titles and the prize-money, promised by the FMJD according to the 64-PWCP-1 regulation, may not be received by a fraud. The justice is at my side. It inspires me to struggle now and it will inspire me to struggle in future, if the next GA will give a negative answer to this appeal.
