About letters named 'GA summary actions FMJD about appeal Fomin' (1) and 'GA 2015 Appeal Fomin against result CPI competition 2013' (2) sent 24.09.2015 General Secretary FMJD Frank Teer to members of FMJD.

In a letter President of the DFR Anatoly Nikitin to President of the FMJD Harry Otten of 11.09.2015 (2) made the following statement:

"Appeal (complaint) from a citizen of the Russian Federation, Andrey Fomin, against CPI about the reversal of the results of the first World Composition Championship (section "problems-64" (64-PWCP-1).

The essence of the Appeal presented by A. Fomin and supported by the DFR....

The CPI President, Mr. V.Shulga, answered to that protest later, on 20.09.2013, and in his answer again he tried to deceive, this time the Draughts Federation of Russia....

The CPI hid from the EB the unresolved conflict, having violated its Statutes by that action. ...

That fraud from the CPI side has no precedent since the CPI creation....

the CPI accepted both false judgments against me and illegal elimination of three compositions of mine; ...

Both titles and the prize-money, promised by the FMJD according to the 64-PWCP-1 regulation, may not be received by a fraud...."

In a letter not signed by anyone, without a date (1) make a statement:

"The executive Board has asked several persons active in the composers world for their opinion... hearing the opinion of several well-known composers from Eastern Europe and West Europe and the Dutch composers organisation KVD..."

Please Mr. Teer and Mr.Nikitin confirm accusations the CPI FMJD the court decisions and other legal documents, also name a group of experts, official expert solutions etc.

The site cpi.fmjd.org lists the official documents about its problems 64-PWCP-I (chapter DISCUSSIONS).

Dear members of FMJD! If the results of the world championship will be changed only on the basis insults and unsubstantiated allegations, it will be a precedent in the world of sports.
