For the Out of the Competition Tests (Urine Sample Only)

For the Out of the Competition test (OC), the players will be selected from our RTP list for this year (Register Testing Pool for 2015). According to the FMJD rules, the OC should be performed any time during 2015, but 2 hours before the first round of a target competition, among the all possible players participating in the RTP.

Day and Time for the Urine Sample collection:

Day: October 1, 2017

Time: **From 7:00 to 11:30**

(All urine samples should be collected by 12:00 in order the test to be considered as OC test.

Number of players and Players Name:

Urine sample should be collected from seven (7) players. The list of 12 players from the RTP list and present at the playing venue by the October 1st 2017 at 7:00am will be used to select the 7 players for the OC test.

The procedure of selection for the 12 players list and the 7players to be tested are described as follow:

From each of the 4-pooling sub groups of the RTP list, 3 players will be randomly selected to have the list of the 12 players.

If the number of players from a pooling sub group is less than 3, then the number of remaining player will be drawing from the largest pooling sub group from the RTP list.

The 7 players for OC doping test will be then randomly selected from the list of the 12 players preselected from the RTP list.

All the selection procedure will start at 7:000 and should be done by 7:30mn.

The sample collection should start at 7:45am and should be done by 11:30am/12:00
